Mission Statement: “*The Kansas Sailing Association (KSA) promotes sailing, sailing education and sailboat racing with an emphasis on One-Design Racing*”. This mission statement guides us in the development and construction of our Sailing Center Facilities and encourages us to promote Sailing, promote Sailing Education, and promote Sailboat Racing.

The KSA club site reaches to the edge of the shore of the most protected harbor on Lake Clinton. The breakwater, with two entrances, provides a sheltered area, which eases boat launching and provides an excellent area to teach beginning sailors. Our dry sail storage lot is close to the waters edge.

The Kansas Sailing Associations calendar includes a broad range of sailing activities for both the racing sailor and social sailing enthusiast. We invite you to join and be a part of the premiere sailing venue in Kansas.

Classes of Membership

Regular Member: Regular Membership includes full voting rights (one vote) and all other privileges of membership including use of the facilities, access to dry storage (with additional fee) and participation in Club activities. Such membership shall include spouse and unmarried children under the age of twenty-three who are members of the household.

Racing Members: Racing members pay an additional fee to cover the costs of the racing program. This fee entitles the racing member to participate in regular club racing. Racing members must own or lease a sailboat that is in a class that is sanctioned by the KSA Race Committee to participate in the racing program. Racing members are entitled to two votes at the annual meeting and any special meetings.

Founding Members: Members who have contributed in aggregate at least \$2000 above regular dues and fees are bestowed the honorary title of Founding Member.

Dry Storage: Regular Members are entitled to place one or more boats in the dry storage lot. All storage fees go toward the development and maintenance of the Sailing Center facilities. Boats that have not paid their storage fees prior to April 1 are also subject to removal from the dry storage lot.
